

This is a copy of a complaint that was filed and reviewed by the Monroe County election board for its Friday, May 15, 2026 meeting. On that occasion, the tabled further consideration, because the complantee is not yet a candidate, and the specifically did not set a hearing on the matter.

Dear Election Board Members,

Recently I was made aware of a media post by Jenee Trimble offering her services in property tax matters in exchange for signatures allowing her to be on the ballot as an Independent this fall. She is not qualified to explain anything on Property assessments. She is only a Level I Assessor which gives her no authority to explain property assessments to taxpayers. She must be a Level III Assessor/Appraiser. Ms. TrimblePP is acting as a Tax Representative, but she has no credentials which are mandatory and issued by the Department of Local Government Finance.

Telling taxpayers that she will help them understand their assessment and how to file an appeal for ten signatures of homeowners in Monroe County is totally unethical as well as I would think illegal!

I would appreciate your consideration of any violation of election laws and remedy for the same.

Your current tax bills that are due by May 10th are based off of LAST year's assessment & they cannot be appealed. The appeal deadline ended on June 15th, 2025. Your NEW assessments will start arriving in about a week & will be available on the GIS on May 1st. They are for NEXT years tax bill payable 2027. The appeal deadline runs from May 1st - June 15th. I forced the assessor into removing her "Trending Factor" from the majority of Residential last year & with having a record number of appeals last year she was forced to walk back on a lot of the Commercial properties as well. That along with the Auditor's \$3.8 million dollar clerical error, many saw a small decrease. Hopefully, for your sakes, the assessor was less aggressive this year with it being an election year. 🙏

I pulled 12-15 hour days, 7 days a week last year from May - September consulting with taxpayers about their appeal rights, the process of appeal & teaching them how to read their Property Record Cards. I won't be able to do that this year. The meetings will not be videoed or live-streamed, so you will need to show up to learn how to read your card & file your appeal. I will try to do as many as I can, but this year it will come with a price. It will cost you 1 sheet of the signatures (10 signatures per sheet) of registered Monroe County voters in advance.
